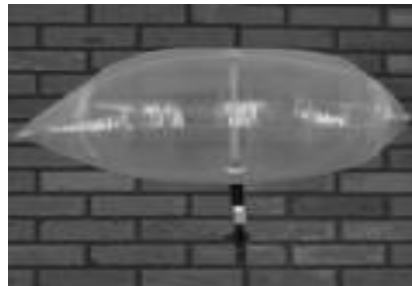




# Chimney Balloon \$35 Mail-In Rebate

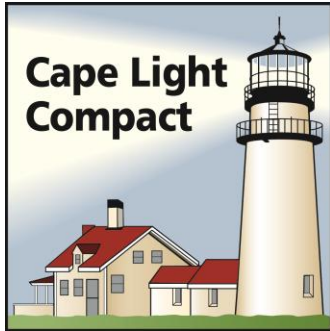

This prevents chimney odor & cold drafts from entering your home, and prevents heat from escaping.
