Joyce Flynn at 2:10 PM moved to enter into Executive Session pursuant to MGL Chapter 30A §21(a) 10 to discuss trade secrets, confidential and competitively sensitive or other proprietary power supply information with a potential vote related to the Cape Light Compact 2019 and beyond power supply program portfolio (renewable energy generation and Renewable Energy Certificate ("REC")); and to review and approve Executive Session Minutes.

Joyce Flynn declared that an open session may have adversely affect the Cape Light Compact's ability to conduct business in relation to other entities making, selling or distributing electric power and energy. 1. Trade secrets, confidential and competitively sensitive or other proprietary power supply information with a potential vote related to the Cape Light Compact 2019 and beyond power supply program portfolio (renewable energy generation and Renewable Energy Certificate ("REC"))

Maggie Downey stated that through analysis the Compact has determined if there were to be an adverse effect to signing a contract that it would only be a negligible, fourth place decimal. Martin Culik asked what it is that the Compact is asking for today. Maggie Downey stated that the Compact wants to know if the Board is in support of us continuing the process of putting a contract together.

Maggie Downey stated that the Farmington Maine Solar Farm is a new, class one eligible facility. This project will be an opportunity for the Compact to hedge a small percentage of the Compact's load, both energy and Renewable Energy Certificates (RECs). Thomas Donegan stated that it will put the Compact in a better pricing and competitive marketing spot. Maggie Downey also stated that this project will help the Compact build a credit rating.

Ron Zweig asked if during the analysis, the Compact factored in health effects. Maggie Downey stated that the Compact did not investigate any societal impacts. Richard Elkin asked what happens if Renewable Portfolio Standard (RPS) changes. Austin Brandt answered that the RPS raises 1% every year. If the RPS raises 3% per year that would make it a better deal by increasing the value of RECs. Maggie Downey stated that the contract would have a fixed price.

Joyce Flynn asked by how much this would be the longest contract the Compact has been in. Maggie Downey answered the longest was about 5 years. David Anthony asked what the risks for NextEra are if the Compact is were to not exist within the 20 years of the contract. Maggie Downey stated that, that will be part of the terms and conditions.

Maggie Downey stated that this is a policy decision. If the Compact decides not to do this, it would just continue to buy RECs year to year. David Anthony asked how much of our power supply load the Compact would ever consider committing to this type of hedging strategy. Austin Brandt replied that it depends on the Board's direction about how close they would like to stay to Eversource's basic service rates. Fred Fenlon asked that if the Compact decides to sign a contract, when would the project start. Maggie Downey answered that it would start before the end of next year. Brad Crowell asked how much it would cost to terminate the contract if the Compact needed to. Jeffrey Bernstein stated that the terms of the termination would be negotiated.

Robert Schofield moved the CLCJPE Board of Directors to authorize the Compact's Administrator to negotiate the terms and conditions for the Farmington, Maine RECs project. Seconded by Peter Cocolis.
