Martin Culik at 4:04 PM moved to enter into Executive (1) pursuant to M.G.L. c. 30A §21(a)(3) to consider strategy and potential vote regarding pending litigation related to the Eversource Rate Case, D.P.U. 22-22; and (2) pursuant to M.G.L. c. 30A §\$21(a)(3) and (10) to review and approve the March 9, 2022 executive session minutes regarding the review and approval of September 9, 2020 and February 9, 2022 executive session minutes concerning pending or imminent regulatory litigation related to Massachusetts Department of Public Utilities (DPU) 20-40, Cape & Vineyard Electrification Offering (CVEO), the 2022-2024 Energy Efficiency Plan, D.P.U. 21-126, the Eversource Rate Case, DPU 22-22, and trade secrets and confidential, competitively-sensitive or other proprietary power supply information related to Low Income Community Shared Solar Project. #### **RATE CASE:**

Rebecca Zachas reviewed D.P.U. 22-22 Eversource Rate Case PowerPoint.

Rebecca Zachas stated that there are three expert witnesses that have been reviewing the case and the discovery that keeps coming in. The Compact has issued six sets of discovery questions this far. She stated that discovery will continue well into May. She stated that the testimony is due April 29<sup>th</sup> and that other intervener parties will be filing as well. Those will be reviewed as well to see if there are any other issues.

Rebecca Zachas stated that the main issue of concern that has been identified relates to commercial customers. Specifically, Eversource is proposing a significant cost shift for commercial customers from Boston to all other regions. The dollar amount of this shift will be quantified once workpapers are received in discovery. The cost shift is unreasonable because costs incurred to benefit Boston customers will shift to other areas of the state. She stated that the Compact's proposed solution is that no rate class should receive a rate decrease and to hold Boston rates at no less than current levels, which will lower rates for other non-residential classes.

Rebecca Zachas stated that there are several bill impacts concerns. She stated that Eversource is proposing increased fixed customer charges which would impact low usage customers. Residential heating rates are being

impacted by the rate consolidation as well. Another issue is the lack of a bill analysis tools. There are also performance metrics that have not been approved that Eversource continues to work under.

Rebecca Zachas stated that there are three concerns related to the performance-based ratemaking (PBR) policy and are not specific to the Compact, they are broader. She stated that they might be taken up by other parties including the Attorney General (AG). The Compact does plan to reach out to the AG and see if we can support the brief if the AG is planning to file and then the Compact could take a lesser role. She stated the first issue is that Eversource is proposing a ten-year PBR plan which means that they would not file a full rate case for ten years. She stated that a lot has happened to the electric industry in the past ten years and that a lot of innovation and change could happen in the next ten years and therefore that waiting ten years for another rate case is quite a long time. The next issue is that Eversource is proposing a price cap when it comes to decoupling. Lastly, there is a lack of flexibility in adding new projects or modifying projects on the list for the major capital projects.

Rebecca Zachas reviewed the estimated budget associated with participating in the Eversource rate case. She stated that it is a very rough estimate since there is a lot that can change that would impact the budget.

David Anthony stated that there has already been time and work put into this already. Is some of the funding coming out of our current budget? Are you are looking to supplement that budget with additional revenue? Maggie Downey stated all that is correct. She stated when the Board had voted to authorize to move forward, at that time Counsel stated the budget approved did not include the costs for this proceeding. Therefore, Compact has been paying out of FY22 budget. David Anthony stated that then this could be an additional \$147,000 needed depending on how things play out. He asked if this case is likely to drag on or is this a relatively secure estimate. Rebecca Zachas stated that she believes it is a relatively secure estimate. She stated that this case itself has a set timeframe. She stated that this budget is based on the issues we have in front of us. There would have to be new major issues that would spark significant changes to the budget estimate.

Colin Odell asked if this was all mill adder and operating budget. Maggie Downey answered yes, it is all operating budget. Colin Odell stated that he would like to see what the mill adder fund looks at before approving the budget. Maggie Downey stated that there is at least \$700,000 in the mill adder fund.

#### Joyce Flynn left the meeting before this vote.

Colin Odell moved the CLCJPE Board of Directors vote amend the 2022 operating budget to increase of \$130,000. Seconded by Robert Schofield.
