NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 24-51 May 10, 2024

Petition of the towns of Aquinnah, Barnstable, Bourne, Brewster, Chatham, Chilmark, Dennis, Eastham, Edgartown, Falmouth, Harwich, Mashpee, Oak Bluffs, Orleans, Provincetown, Sandwich, Tisbury, Truro, Wellfleet, West Tisbury and Yarmouth, and Dukes County, organized and operating collectively as Cape Light Compact JPE, for approval of revised 2024 Energy Efficiency Reconciling Factors for effect July 1, 2024.

On April 12, 2024, the towns of Aquinnah, Barnstable, Bourne, Brewster, Chatham, Chilmark, Dennis, Eastham, Edgartown, Falmouth, Harwich, Mashpee, Oak Bluffs, Orleans, Provincetown, Sandwich, Tisbury, Truro, Wellfleet, West Tisbury and Yarmouth, and Dukes County, organized and operating collectively as Cape Light Compact JPE ("Compact"), filed with the Department of Public Utilities ("Department") a petition seeking approval of revised 2024 energy efficiency reconciling factors ("EERFs") for effect July 1, 2024. The Department docketed the Compact's petition as D.P.U. 24-51.

An EERF collects additional funds for approved energy efficiency programs when the cost of implementing those programs exceeds other funding sources. See G.L. c. 25, § 19(a). The EERFs are designed to: (1) collect costs associated with the Compact's energy efficiency program implementation in excess of other funding sources; and (2) reconcile expenses and revenues from the previous year's program implementation.

The Department approved the Compact's Three-Year Energy Efficiency Plan ("Three-Year Plan") and associated budget in 2022-2024 Three-Year Energy Efficiency Plans, D.P.U. 21-120 through D.P.U. 21-129 (2022). On December 27, 2023, the Department approved the Compact's 2024 EERFs for effect January 1, 2024, subject to reconciliation after further investigation. Cape Light Compact JPE, D.P.U. 23-135 (2023). The Compact now proposes to revise its 2024 EERFs to incorporate an \$6,178,996 increase in its Three-Year Plan budget associated with the Department's approval of the Compact's request for a mid-term modification in Cape Light Compact JPE, D.P.U. 23-58, Stamp-Approved Filing (March 14, 2024).

The Compact proposes the following revised EERFs for effect July 1, 2024: (1) 3.898 cents per kilowatt-house ("kWh") for its Residential and Income-eligible sectors; and (2) 1.558 cents per kWh for its Commercial and Industrial ("C&I") sector.

If the Department approves the revised 2024 EERFs as proposed, a typical residential customer (R-1) using 530 kWh of electricity per month will experience a monthly bill increase of \$9.58 (or approximately 5.31 percent). A typical low-income residential (R-2) customer using 475 kWh of electricity per month will experience a monthly bill increase of \$4.98 (or approximately 5.27 percent). C&I customers will experience increases to monthly bills ranging from 1.33 percent to 2.26 percent. For specific bill impacts, please contact the Compact as shown below.

The Department strongly encourages public comments to be submitted by email using the methods described below.
