#### LOW INCOME COMMUNITY SHARED SOLAR STRATEGY (LICSS) – CON EDISON:

Thomas Sweeney, ConEdison Clean Energy Business (CEB), reviewed the Low-Income Community Shared Solar Strategy for Cape Light Compact Municipal Aggregation Program PowerPoint. He stated that Municipal Aggregation Programs are now recognized by the Department of Energy Resource (DOER) to increase access to Low Income Community Shared Solar subscribers. Low-income households that participate in the program are not taking on any economic risk. There is also no economic risk for the Compact or towns. Solar credits go from projects to the Compact and then they are disbursed to the Compact's supplier. He stated that there would be a 20-year contract between the Compact and Con Edison CEB.

Valerie Bell asked if the Compact would be taking on more administrative work to manage the program. Maggie Downey answered yes. She stated there is a fee from ConEdison CEB to the Compact to cover those costs. Valerie Bell asked if there must be a minimum number of subscribers for the contract to continue. Sweeney stated that the volume of low-income customers the Compact has is why this program will work. Richard Elkin asked how numbers will change over time or if everything is fixed. Sweeney stated that the dollar amounts paid for the power and what Con Edison CEB will pay the Compact is fixed.

Sweeney reviewed the economics slide. He stated that the Con Edison CEB will pay \$0.015/kWh for allocated production per contracted project for participating low-income subscribers. Con Edison CEB will also pay the Compact an annual administration fee of \$25,000 and will advance the first year Administration Fee to negotiate forms of agreements in good faith with Con Edison CEB.

Richard Elkin asked what percentage of our total capacity of low-income customers does the program need. Austin Brandt stated that he does not have an exact answer. He stated that it is important to remember that we are not talking about kilowatt hour ("kWh") to kWh, we are talking about dollars to dollars. Therefore, it is not as much about the load as it is about matching that \$0.015 that the Compact will get from Con Edison CEB for each kWh its project produces to the total Eversource bill of all the Compact's low-income customers.

Peter Cocolis asked how the customers would see the benefit. Sweeney stated that the customers would see a reduction in their energy supply charges on their electric bill. Richard Elkin asked if it would clearly state on their bill that they are receiving this reduction from this program. Austin Brand stated that it will not explicitly state that on the bill. Erik Peckar asked if the administration fee was per project. Maggie Downey stated that that is the cap for each year.

Alan Strahler asked for confirmation that the program is not costing the Compact anything and that the Compact's role is primarily to reach out to low-income subscribers and get them relief on their energy bills. Maggie Downey stated that that is correct. She stated it is a part of the Compact's municipal aggregation plan where the Compact looks to get the best rates for each of the customer classes. Sue Hruby asked what the timeline on this. Maggie Downey stated that hopefully the last quarter into 2021 is when subscribers should start seeing benefits.

#### <u>LOW INCOME COMMUNITY SHARED SOLAR – BCK:</u>

Rebecca Zachas reviewed the Low-Income Community Shared Solar PowerPoint. She stated that DOER released a set of revised guidelines, including the Guideline Regarding Alternative Programs for Community Shared Solar Tariff Generation Units. She stated that some of the revisions are very significant to the point that it could affect municipal aggregation's ability to offer these programs.

Rebecca Zachas stated that public comments were due to DOER on March 5, 2021, and that the Compact did submit comments. These comments were to strike the requirement to file an amended municipal aggregation plan with the Department of Public Utilities (DPU) to offer a LICSS program, strike language regarding potential future DPU directives, clarify whether a low-income customer may take multiple discounts from LICSS projects, revise language related to allocation of energy or energy credits, clarify revisions related to LICSS enrollment process, and revise use of term "municipality" to "aggregator" to reflect multi-municipality aggregations.

Rebecca Zachas stated that some of the other commenters she is aware of as of right now are the City of Boston, Con Edison, and Northeast Clean Energy Council/Ameresco.
