**Explanatory Notes:**

(1) Clean Energy Standard ("CES"), Clean Energy Standard Existing ("CES-E"), Clean Peak Energy Standard ("CPS"), Renewable Portfolio Standard ("RPS") and Alternative Portfolio Standard ("APS"): Legal/regulatory requirements that obligate retail suppliers to obtain specific types/amounts of RECs from clean and renewable sources based on percentages of retail customers' energy usage. CES, CES-E, CPS, RPS and APS requirements may only be altered by changes in Massachusetts laws or regulations.

(2) Additional REC Content: The Commonwealth of Massachusetts requires that all electric supply products include, in 2025, a minimum of 63.1137% clean energy resources that are located within the New England region, including at least 30% of which the Commonwealth has designated as "premium" renewable resources. This product includes 100% renewable energy resources. 1% of the resources that exceed the minimum requirement are located within the New England region and have been designated as "premium" resources by the Commonwealth. All remaining resources that exceed the minimum requirement may be located outside of the New England region and have not been designated as "premium" resources by the Commonwealth. 100% of the supplier's revenues from the sale of "Additional REC Content dedicated to New Renewables Project Funding" will be deposited into the EarthEra Renewable Energy Trust (EarthEra), which is a 3<sup>rd</sup>-party trust with US Bank acting as the trustee. Pursuant to EarthEra's trust agreement, these funds may only be used for the construction of new renewable energy projects. Your retail energy supplier has also committed to direct its contracted supplier fees into the EarthEra Renewable Energy Trust (for avoidance of doubt, there are no additional fees that are being charged to supply this service). The Additional REC Content charge reflects the sum of a) the cost of the voluntary RECs and b) the contracted supplier fees your supplier has committed to deposit into the Trust.

MA Class 1 RECs sourced from the Farmington Solar Project are expected to comprise the majority of the 1% of the resources exceeding the minimum requirement that are located within the New England region ("premium" resources). The cost of both energy and RECs sourced from the Farmington Solar Project is included in the "Energy" line item above.

(3) Capacity ensures that the New England power grid will have sufficient generation resources to meet customers' instantaneous and future demand for electricity. These costs are mandatory and are applied uniformly to all New England power customers.

(4) Ancillary Services: These services ensure the reliability and stability of the New England power grid transmission system. These costs are mandatory and are applied uniformly to all New England power consumers.

(5) Distribution Losses: The New England power grid is not 100% efficient and some electricity is consumed during its transmission from electric power generators to your home or business. Eversource determines these consumed quantities as a percentage and they must be paid for: 6.714% for Residential/Commercial customers and 4.549% for Large Industrial customers. These loss figures may be changed by Eversource.

(6) Fee charged by Eversource to Suppliers to recover non-payment to Eversource by its customers (bad debt costs); Eversource purchases Suppliers' receivables at face value less this fee which is in the form of a percentage. The fee is 1.55% for residential, 0.65% Small C&I, and -0.01% for large C&I customers respectively. These fees may be changed by Eversource.

(7) This rate applies to Cape Light Compact's Commercial customers. Customers with the following Eversource rate codes receive the Compact's Commercial Rate: G1, G5, G5, S1, S2
